Foston Parish Council Comments on Planning Application – \$21/0366

Location: Foston Lodge Newark Hill Foston NG32 2LQ

Proposal: Erection of building and change of use from agriculture to agriculture contractors yard/storage.

Applicant: CMB Contracting

Foston Parish Council objects to this application for the following reasons.

Having regard to the nature, location and design of the proposed development it is considered that the proposal would lead to an acceptable commercialisation of agricultural land and an intrusion into the open countryside to the detriment to the character of the village and the open countryside. The proposal would not contribute to the conservation or enhancement of the character of the area and in addition, the proposal does not fall within the exceptional circumstances set out under Policy SP1 of the Core Strategy. The proposal would be contrary to Core Strategy Policies SP1, EN1, as well as the provisions of Foston Neighbourhood Plan Policies FNP01 and FNP12

Please see the final two pictures at the end of this submission which show how intrusive this new building is in comparison with the old Dutch Barn

In addition to the above, the Parish Council wishes to raise the following points regarding the application.

The applicant and/or his agent are being disingenuous when they claim several times that the applicant's business is solely an agriculturally based one. The following are extracts from Planning Statement submitted with the application.

- 1. His business cannot be termed as anything other than "Farming" in the terms of the South Kesteven Local Plan and the NPPF.
- 2. The applicant business is solely concerned with Farming and Forestry.
- 3. The application is for a building to support an agricultural concern. It will house machinery which can only be termed as that used in agriculture.

A visit to the applicant's Facebook page clearly demonstrates that he is in no way a purely agricultural business, see attached pictures in Appendix 1 These pictures clearly demonstrate that the applicant's business is categorically not a purely agricultural contracting business.

On the Town and Country Planning Act 1990 application form the Description of the Proposal is "New agricultural building"

The Supporting Planning Statement is titled: Erection of Building to House and Maintain Agricultural Equipment

The application is clearly not for a new agricultural building but for building for a civil works contractor who carries out both civil and agricultural work.

The Planning Statement title includes the words "maintain" so we are no longer looking at a facility purely for the storage of large machinery, but a workshop where maintenance and repair will be carried out?

On both the 24th and 25th May 2020 the applicant's own Facebook account describes the work being carried out as the construction of a new "Headquarters" and not just a storage facility for his machinery. See Appendix 2 for screenshots

There is clearly a major change of use intended here and the applicant should be requested to amend his application to include that change of use and detail the Classes of Use that he wishes to change from and to.

The safety of the access to and from the applicant's site onto Newark Hill from what is best described as the "Chicken Farm" track was the source of great concern when the application for the Chicken farm in Foston was made. (S12/3241)

The approval of this application would allow the Chicken Farm Track/Newark Hill junction to be used by at least twenty slow moving pieces of heavy machinery as listed by the applicant on Page 9 of his "Supporting Planning Statement"

In addition to this traffic the creation of a new "Headquarters" and Maintenance facility at this location would undoubtedly lead to the generation of additional traffic, with visiting customers arriving and leaving by vehicle.




