The Parish Council is considering the installation of CCTV cameras on the three entrances to the village and on the playing field play area on Chapel Lane.

The CCTV would act as a key tool in detecting and preventing crime, disorder and antisocial behaviour. The cameras would not be monitored on a 24 hour basis but the recordings from the cameras could be viewed following any instances of crime, disorder and antisocial behaviour.
