## **New Defibrillator**

We would like to express our thanks to our District Councillor, Cllr Jane Wood who has confirmed a grant to Foston Parish Council for £600.00. This is to go towards an additional defibrillator for the village. We believe that the best place for our second defibrillator is on the outside of the Village Hall where it will be available day and night.



## **Multipurpose Sports Hall and Scout Hut**

Our Parish Clerk James Stanley submitted an application to the Awards for All fund for assistance with professional fees to support the commencement of our project to replace the Gorrie Hall Scout Hut. All being well the new building will be located on the playing field and we are hoping for a multi-purpose Sports/Scout Hall big enough to play Badminton and team games when the Hall is not being use by the Scouts. The Parish Council is pleased to announce that we have received £4,375.00 from the lottery fund Awards for All.

We are now liaising with Focus Consultants who will provide professional input and research for our community building. They

are putting together a survey in order to progress our joint project forward. The next step is the consultation process so a questionnaire will be landing in your letter box or your inbox on-line in the coming weeks. So please keep an eye out for it.



# **Best Kept Village Competition – 2019**

We now have the results of the Best Kept Village Competition and we have gained some good marks but we can still do better. We got 113 out of a possible 150 on the score sheet. The score sheet can be found on the Village Noticeboard on Main Street or attached to this Newsletter.

The Judges appeared to get a bit confused when judging the section called "Public Premises 2" as they describe a bus shelter which is something the village has always wanted, but never had.

Last year on the score sheet for Best Kept Village it stated that if any of the features do not exist in a village they would not be penalised. So we need to bring this point to the attention of the Judges because we were penalised by being given just 5 points for Business Premises out of total of 20. That does seem somewhat unfair!

Once more we would like to thank everybody for keeping their gardens tidy and to Janet Bray and the Conservation Group for all their hard work keeping the village sign's garden looking pretty. Not forgetting the volunteers who tirelessly worked during the clean-up weekends cutting down overgrown areas in the rain, thank you all.
