Chapel Lane Footpath

IMPORTANT REMINDER

This is totally unacceptable to the family and if they get really fed up with

Stopping up of land in front of Black Horse Cottages



The term 'stopping up' means that once such an order is made, the highway land ceases to be a highway, road or footpath ie the highway rights are extinguished in law.

The area to be stopped up is marked out in white marks in front of the Black Horse Cottages. If successful the area marked would be fenced. Then the land is free of any Highway Authority control. It is common law presumption that the subsoil of the area stopped up reverts to the landowners. The land can then be enclosed or developed.

Foston has had a fantastic response to the call for volunteers during the ongoing Coronavirus/Covid 19 pandemic. We would like to thank everybody for helping and supporting their neighbours. The Parish Council would now like to convert our Community Aid Network into a Good Neighbours Scheme with the help of Community Lincs in Sleaford.

The intention is to combine the Neighbourhood Watch, Emergency Plan Group within the umbrella of the 'Good Neighbours Scheme' where we can help residents and the wider community in an emergency or on an ongoing, or one off basis if and when needed.

We will be distributing a questionnaire within the village to find out what sort of help is needed now and in the future so we can plan for most eventualities. We have already asked the Community Aid Network volunteers if they are willing to put themselves forward for the Good Neighbours scheme and so far we have had a positive response.

If you are willing and able to help with the Good Neighbours Scheme and we have not already heard from you please contact Christina Lees, Tracey Gardner or our Parish Clerk James Stanley, thank you.

We will need to find funds because we will need indemnity insurance, dedicated phone, tablet for records and volunteers will have to be checked by the Disclosure and Barring Service (DBS's) Standard check.

Speed Monitoring Device

The Parish Council has over the last four years been looking at the idea of a mobile speed monitoring device. We have put aside money each year and we now have £3000 in order to purchase a Radar Speed Sign. This will hopefully allow the Parish Council to respond to the concerns raised by residents regarding speeding in the Village.



This has been an ongoing problem for years and this device will hopefully warn people that they are driving too fast and give us the data necessary to raise concerns with the Police and Highways Authority.
