Temporary traffic restriction: Foston

Alternative route or access arrangements: Diversion routes and vehicular or pedestrian access arrangements will be signposted.

Protecting yourself against scams

If you think an email could be a scam, you can report it by forwarding the email to: report@phishing.gov.uk. Send emails that feel suspicious, even if you're not certain they're a scam – they can be checked.

Most phone providers are part of a scheme that allows customers to report suspicious text messages for free by forwarding it to **7726**. If you forward a text to **7726**, your provider can investigate the origin of the text and arrange to block or ban the sender, if it's found to be malicious.

If you've lost money or provided personal information as a result of a phishing scam, notify your bank immediately and report it to Action Fraud: <u>www.actionfraud.police.uk</u>

during the previous 12 months have worked in the parish (as your principal or only place of work), or;

for the whole of the previous 12 months lived in the parish or within three miles of the parish boundary.
