FOSTON PARISH COUNCIL (FPC)

Minutes of the FPC meeting held on 4 July 2017 at 7.30 pm

Public Forum: Two members of the public were present. Items raised were: a) the litter and fly tipping at Fallow Ford; b) verge safety and blackthorn encroachment; c) the stopping up of land outside Black Horse Cottages,

The Parish Council meeting started at 7.45 pm

40/17 Apologies were received from District Cllr P Wood.

41/17 Disclosable Pecuniary Interests: None

42/17 Minutes of the meeting held on the 2 May 2017: were unanimously accepted by Council and signed by the Chairman as a true record.

43/17 Stopping up land outside Black Horse Cottages Council noted residents' comments from the informal consultation via the Parish Newsletter. Consultation by LCC starts on 5 July 17 when FPC will formally consult with residents. Council will ask LCC for a white line to show the stopping up area. Ongoing concerns of safety at the corner were noted, regardless of the stopping up.

44/17 Playing Field and MUGA

- a) Options for clearing up the fallen tree were discussed and due to insurance concerns a local contractor will be asked to remove the tree.
- b) Council resolved to write to WREN regarding a combination padlock for the MUGA.
- c) A locked storage cage remains a priority. Council resolved to find a metal fabricator to make a metal lid.
- d) Notices to say 'No Studded Boots please' and arrangements for tennis playing times will be displayed.
- e) Foston Playing Field deeds are with the Chairman. Council expressed their disappointment that the decision to retain the status quo regarding the village hall and new community building was taken solely by the Village Hall committee and residents were not asked for their views. Council resolved to email the Village Hall committee with an offer of help including funding for a consultation.
- f) Quotes awaited for playing field and gate, picnic bench hardstanding. There are currently no football clubs wanting the Foston pitch.

45/17 Roads and Footpaths:

- a) Council resolved the purchase of LCC 3 Poultry Farm signs £1140 document circulated
- b) Council resolved to ask LCC for the provision of 2 wildlife signs on Newark Hill
- c) Council resolved to map verges needing grass cutting with a view to getting a quote
- d) Council resolved to ask Highways England for a sign for Foston on A1 at Long Bennington North bound and sign from A1 on Main Street entrance saying 'No admittance for Poultry Farm traffic'
